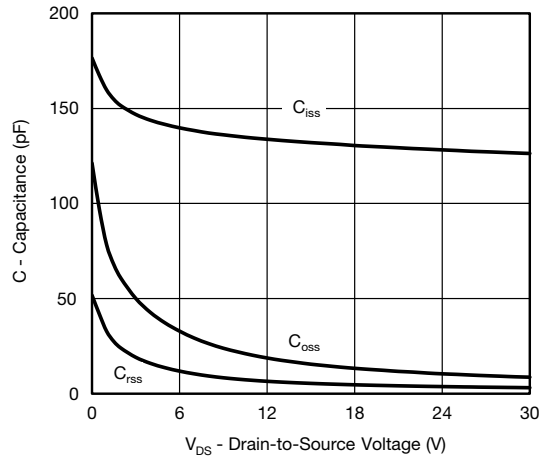

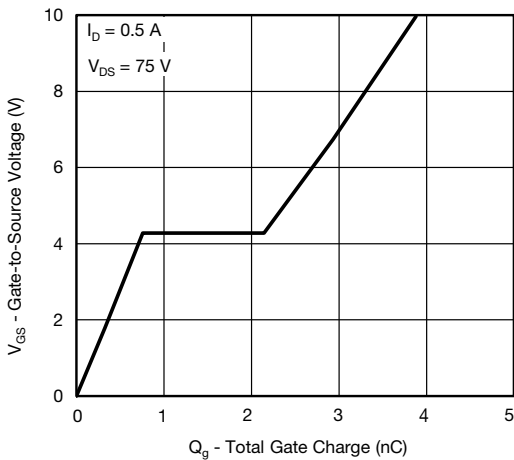

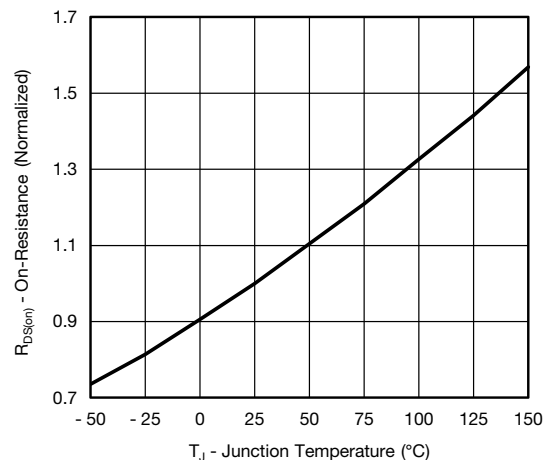
**On-Resistance vs. Drain Current and Gate Voltage**

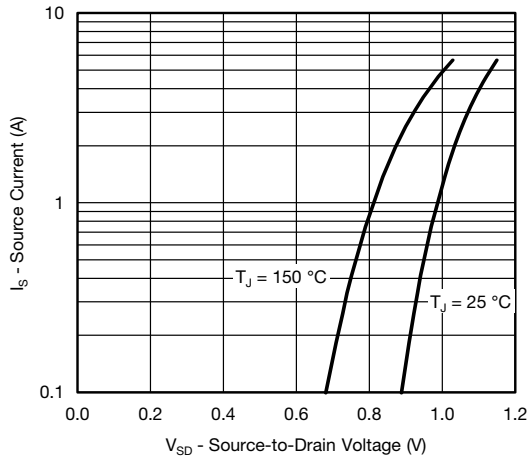


**Gate Charge**

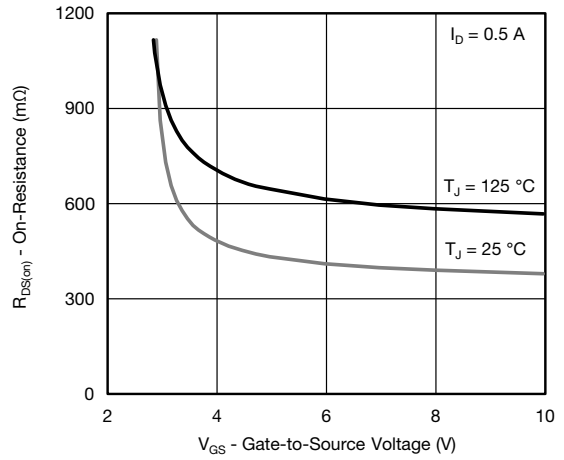


**On-Resistance vs. Junction Temperature**

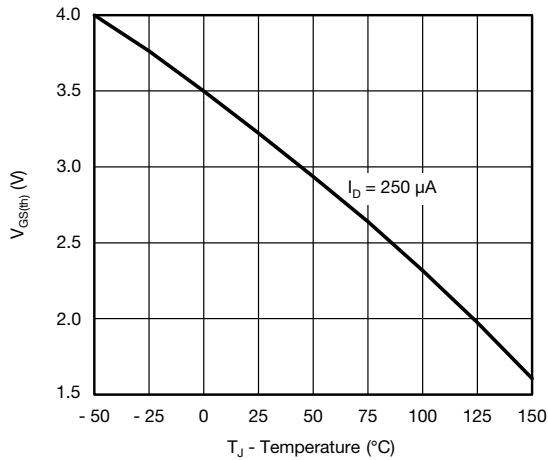

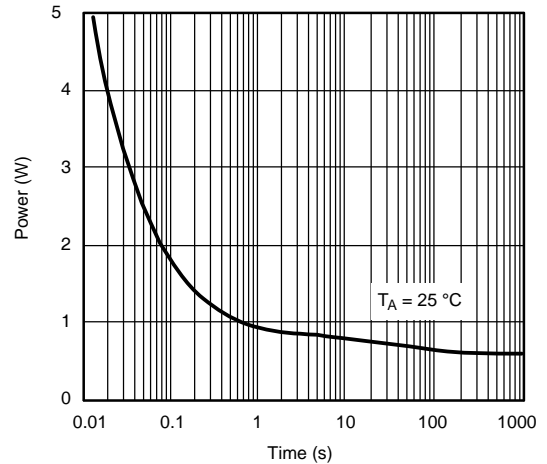
**Source-Drain Diode Forward Voltage**



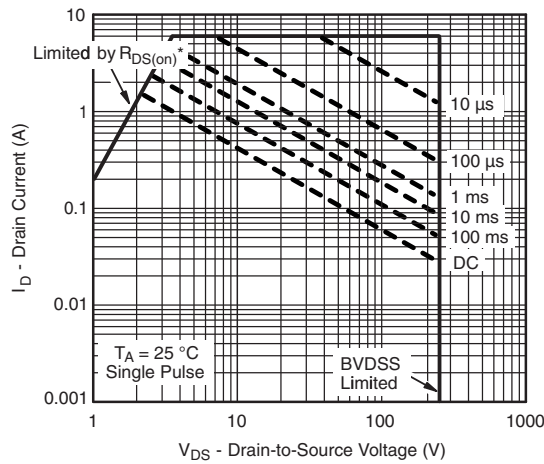
**On-Resistance vs. Gate-to-Source Voltage**



**Threshold Voltage**

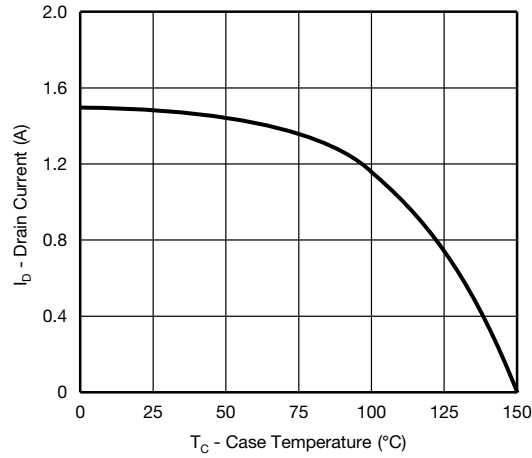


**Single Pulse Power (Junction-to-Ambient)**

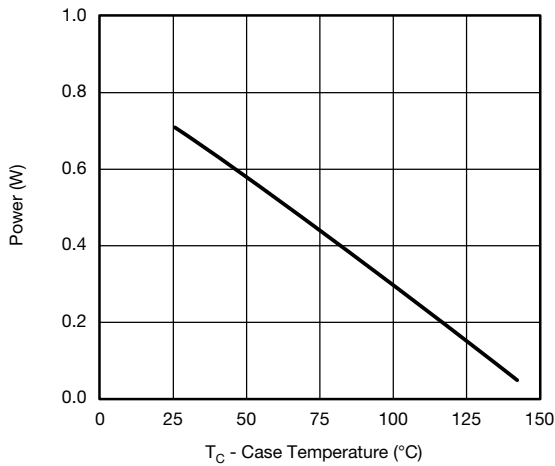

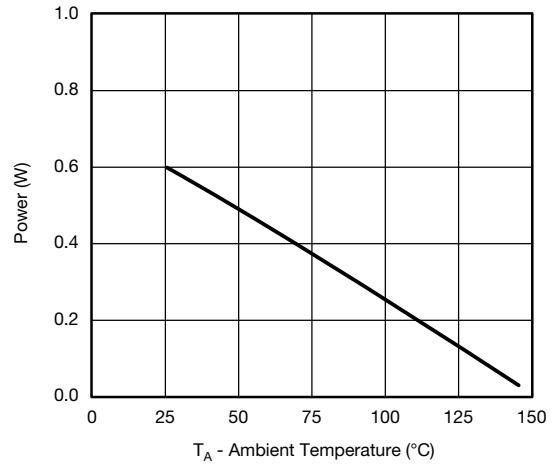

**Current Derating\***



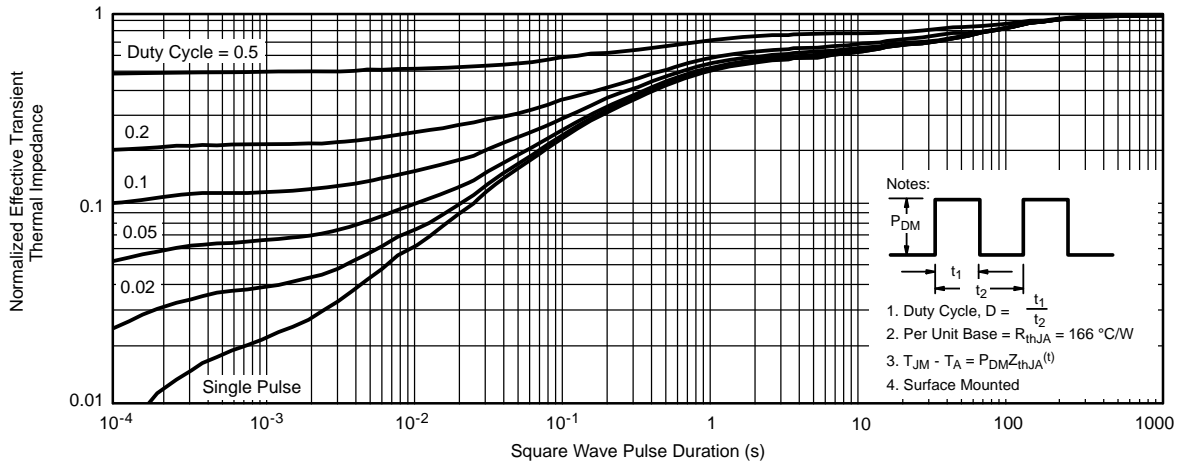
**Power Derating, Junction-to-Foot**



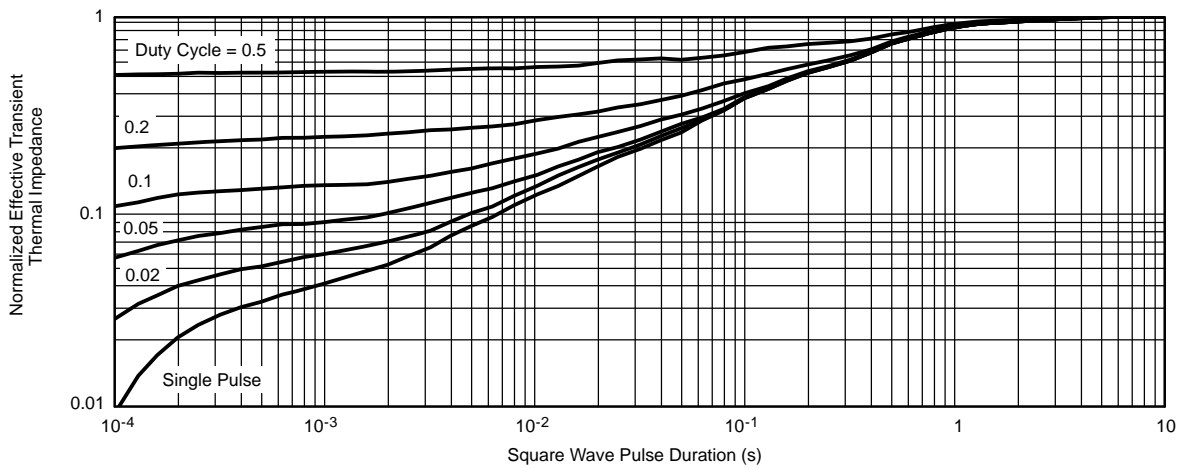

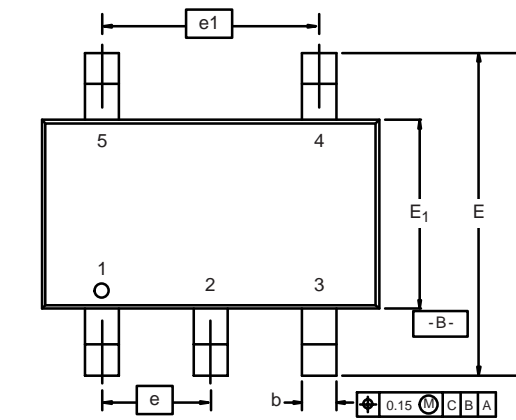


**Normalized Thermal Transient Impedance, Junction-to-Ambient**

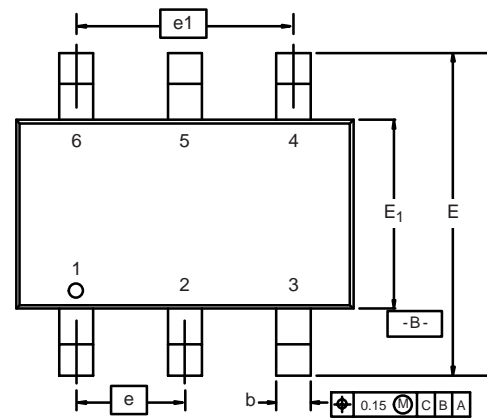


**Normalized Thermal Transient Impedance, Junction-to-Foot**

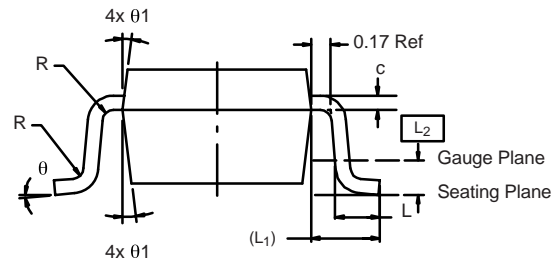
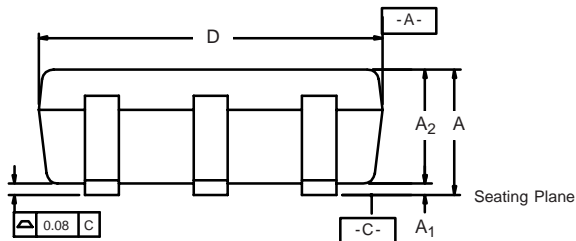
**SOT23: 5/6-LEAD Package Outline**



**5-LEAD TSOP**

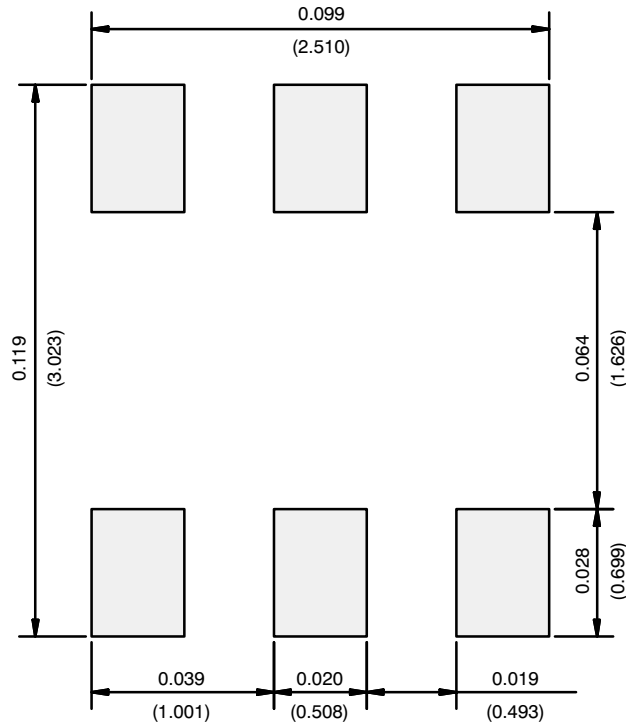
