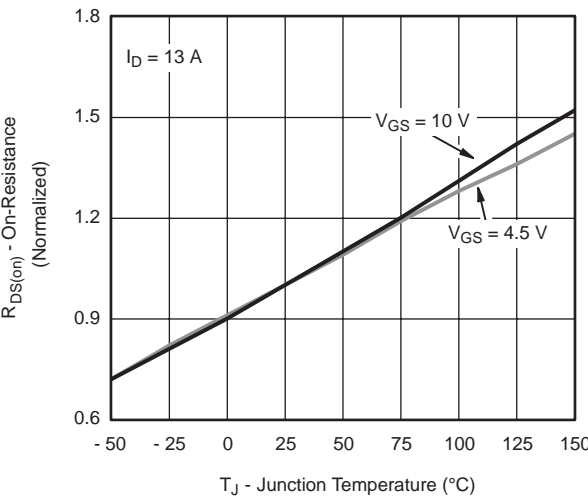
**On-Resistance vs. Drain Current**

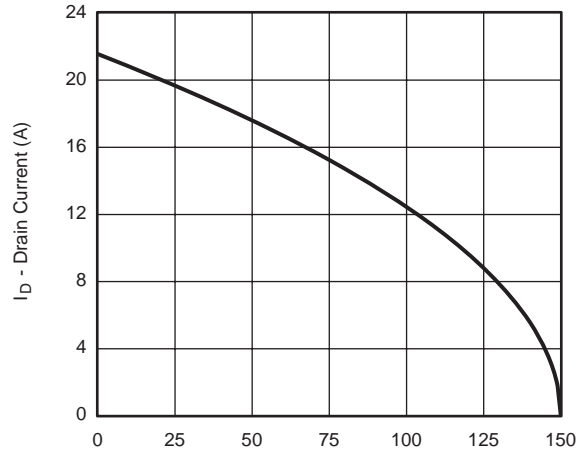
**On-Resistance vs. Junction Temperature**

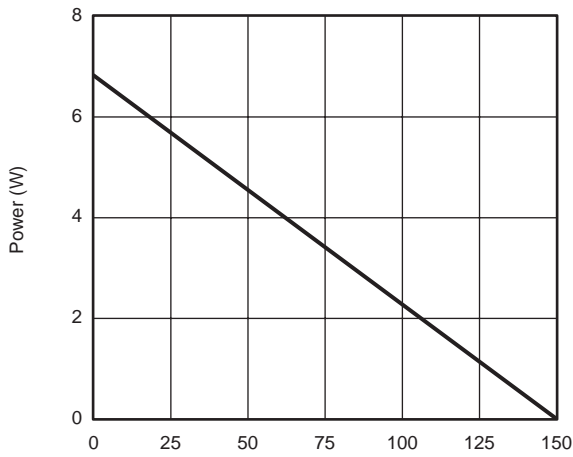

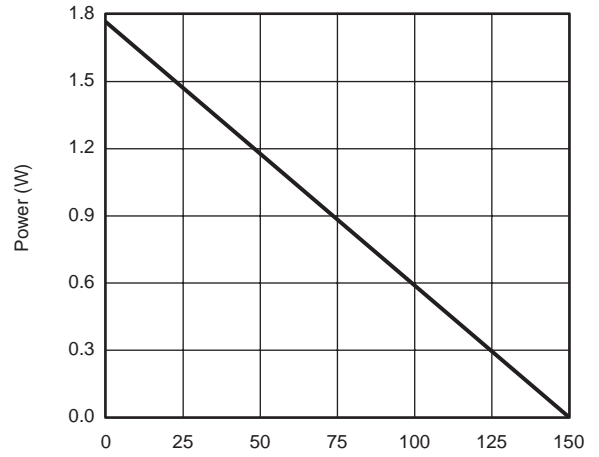

**Current Derating\***



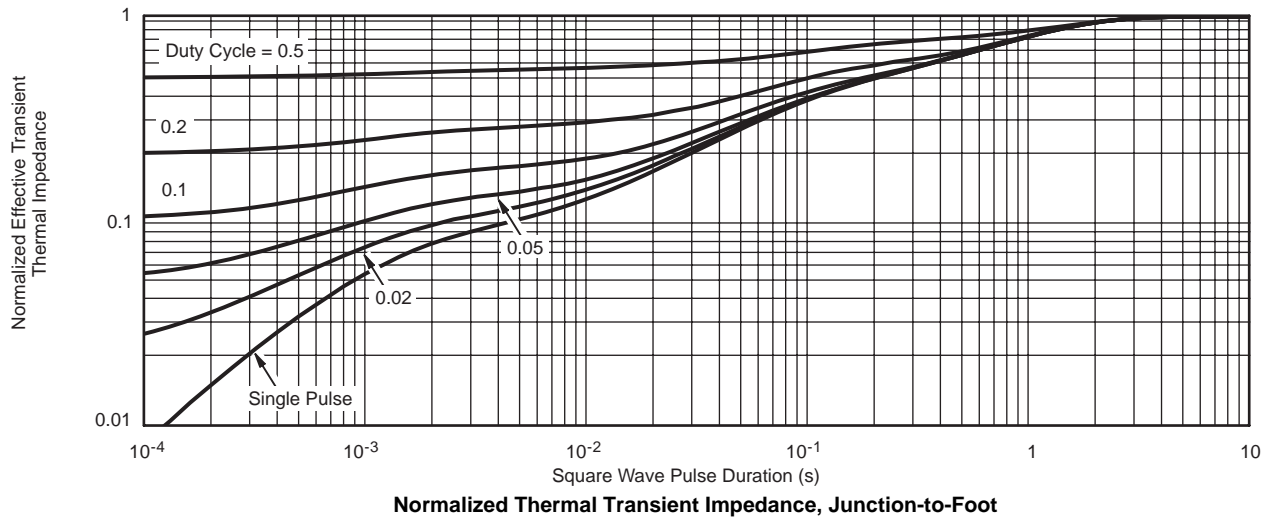
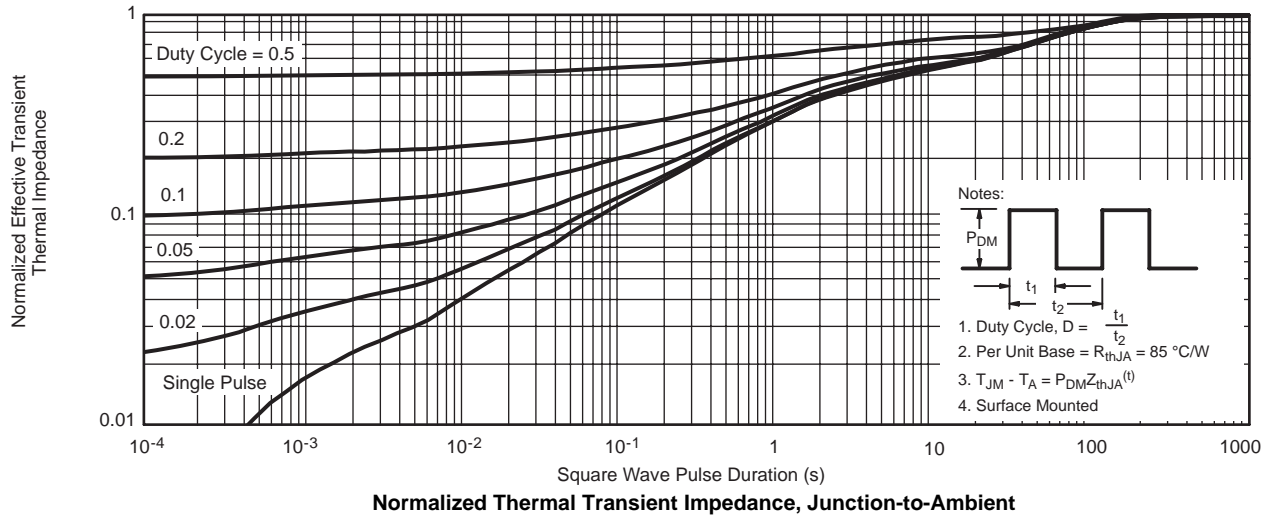
$T_C$  - Case Temperature (°C)
