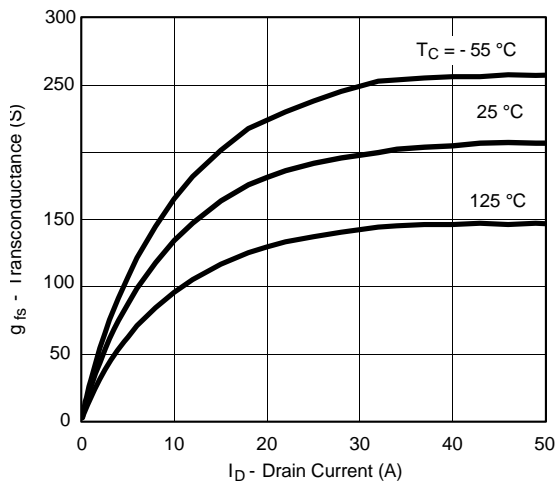

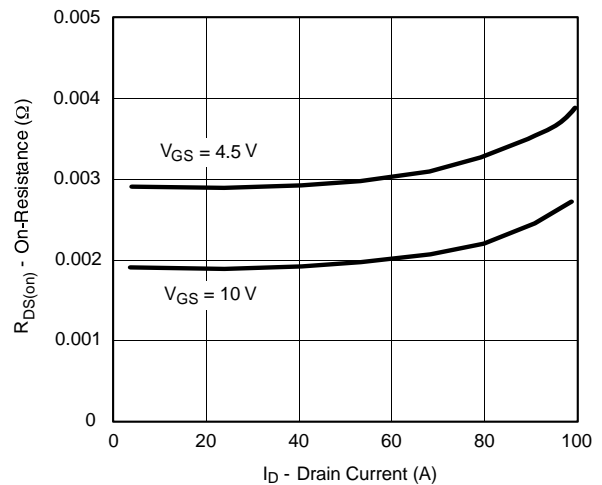

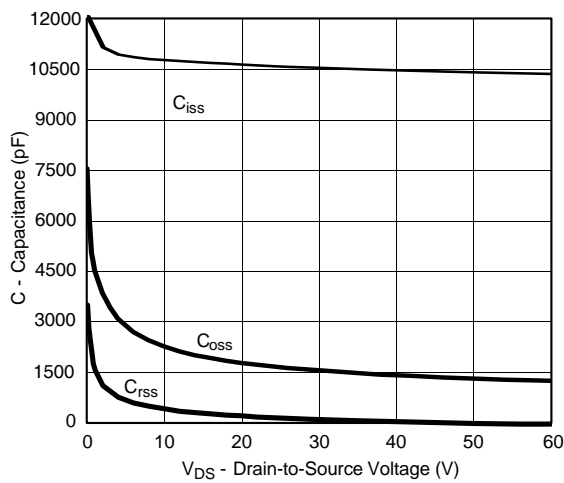

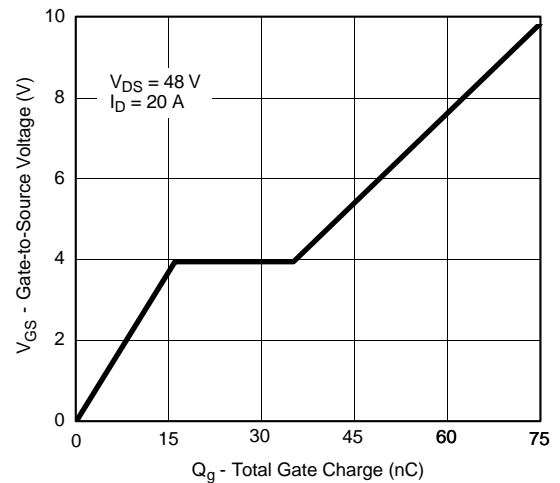
Transconductance



On-Resistance vs. Drain Current

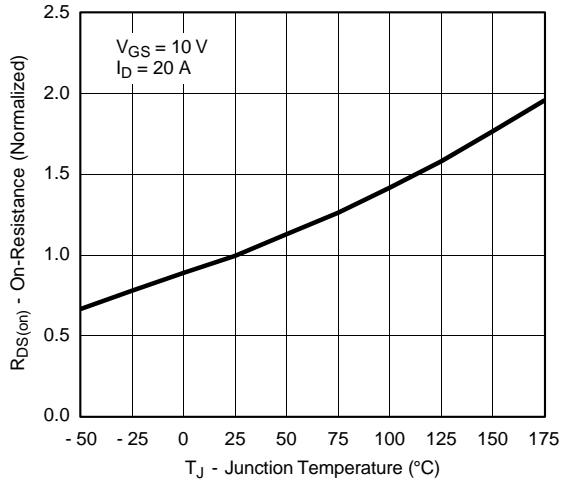


Capacitance

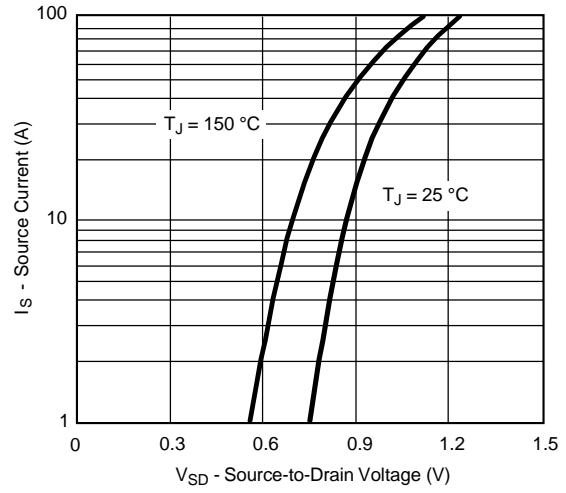


Gate Charge

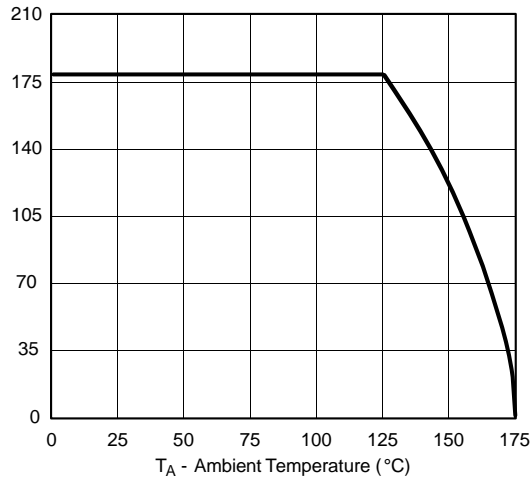


On-Resistance vs. Junction Temperature

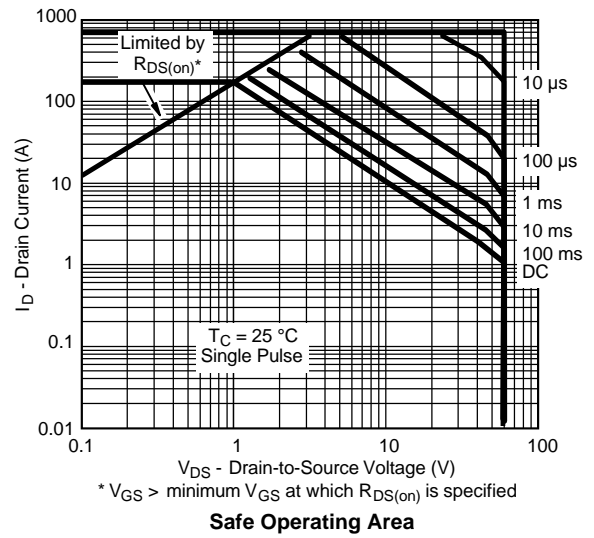


Source-Drain Diode Forward Voltage

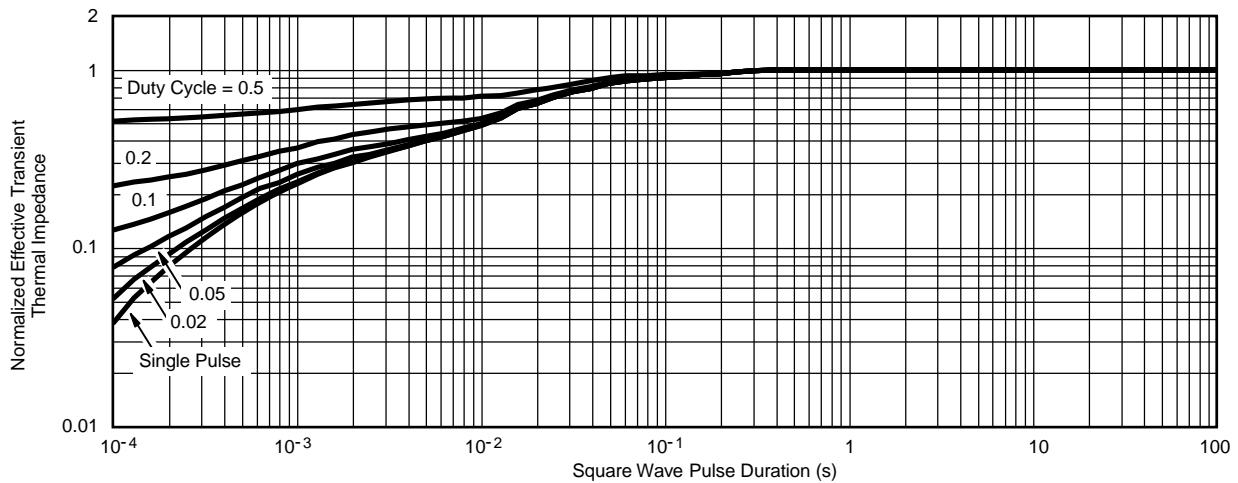

Maximum Drain Current vs. Ambient Temperature

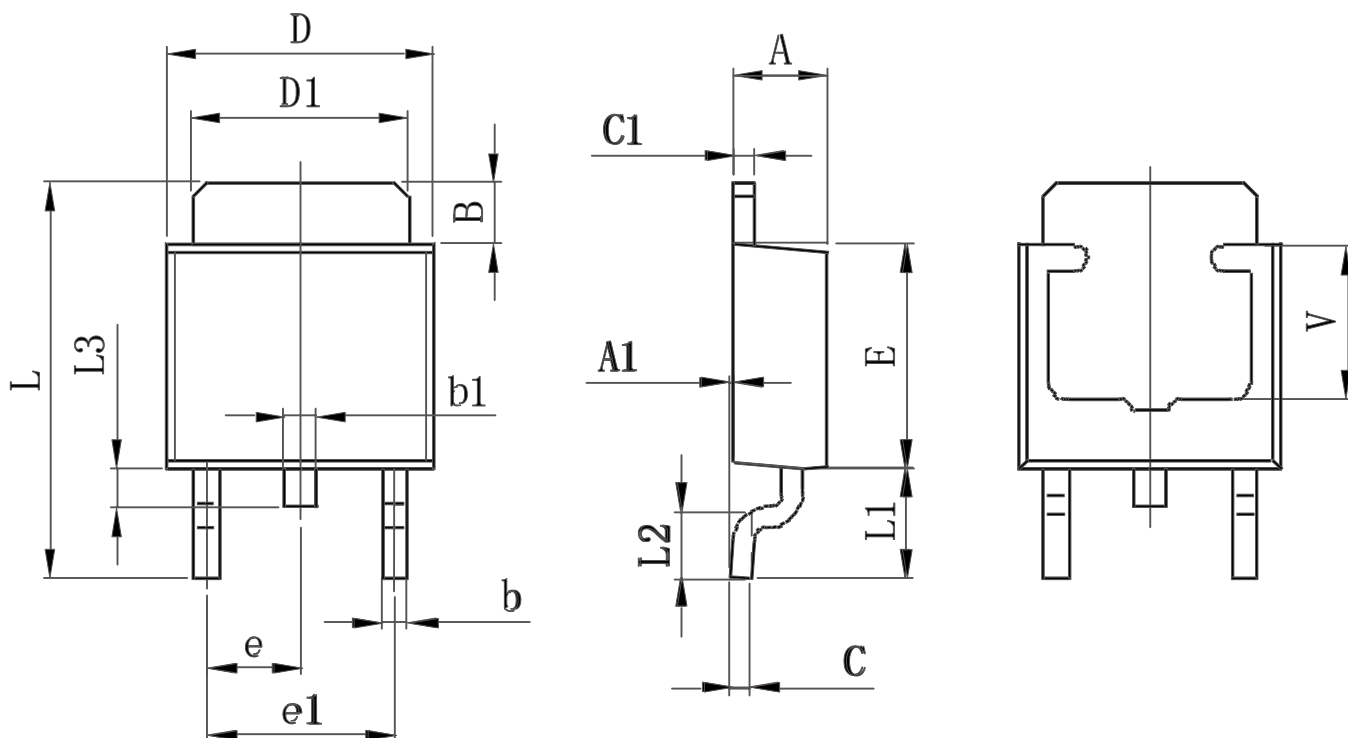


Safe Operating Area



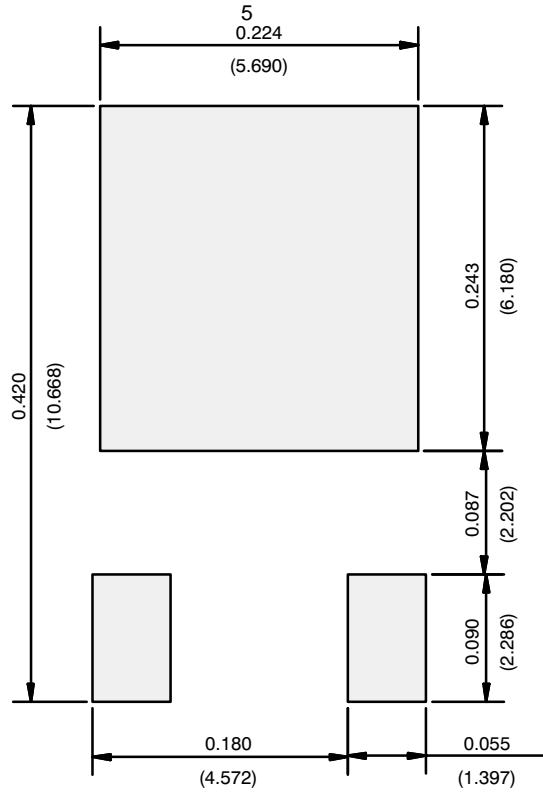
Normalized Thermal Transient Impedance, Junction-to-Case
