


TYPICAL CHARACTERISTICS (25 °C unless noted)



V_{DS} - Drain-to-Source Voltage (V)








V_{DS} - Drain-to-Source Voltage (V) **Capacitance**






On-Resistance vs. Drain Current








On-Resistance vs. Junction Temperature



Maximum Avalanche Drain Current vs. Case Temperature




Source-Drain Diode Forward Voltage





Normalized Thermal Transient Impedance, Junction-to-Case
