





#### **Typical Output Characteristics**




On-Resistance vs G-S Voltage





Normalized  $V_{GS(th)}$  vs  $T_J$ 

Normalized R<sub>DSON</sub> vs T<sub>J</sub>









#### **Normalized Maximum Transient Thermal Impedance**








**Unclamped Inductive Waveform**
