




Drain to Source Voltage **Output Characteristics**




Gate to Source Voltage
Drain to Source Resistance vs. Gate to Source Voltage




Source to Drain Voltage **Body Diode Forward Characteristics**



Gate to Source Voltage Transfer Characteristics




Drain Current Drain to Source Resistance vs. Drain Current



Drain to Source Voltage Capacitances






Gate Charge Gate to Source Voltage vs. GateCharge




T_C - Case Temperature



Source to Drain Voltage Safe Operating Area, Junction-to-Ambient




T_C - Case Temperature
