





Gate to Source Voltage



Drain to Source Voltage Capacitances






Gate to Source Voltage vs. GateCharge



 $T_{C} \textbf{-} \textbf{Case Temperature}_{\text{Current Derating}}$




Source to Drain Voltage Safe Operating Area, Junction-to-Ambient
